Criminal Court

If you were cited with a criminal violation, you **MUST** appear for the court date listed on your ticket. If you are unable to appear, you must contact the court in writing before your court date.

To file a motion

Civil Traffic Court

You must take steps to resolve your case on or before the date on your ticket to avoid the following:

- A Default Judgement and assessment of fines and court fees
- Notification to the Motor Vehicle Department to suspend driving privileges
- Prevention or renewal of any Arizona vehicle registration where you are the registered owner
- Notification to the Arizona Department of Revenue to intercept your Arizona State tax refund or lottery winnings to pay for any outstanding balance
- Notification to a collection agency and additional collection fees, including a \$49 delinquency fee

The following information are instructions on how to resolve your case without coming to Court. Please read carefully.

Defensive Driving School

- You may be eligible to attend a class online or in person in order to have one charge dismissed. For more information, please go to: [City of Scottsdale - Defensive Driving Course \(scottsdaleaz.gov\)](#)
- If you complete Defensive Driving School you will not have to pay the fine for that charge, and it will be dismissed.
- You are only eligible to attend DDS for one charge within 12 months from the date of your last violation for which you were authorized to attend a defensive driving school.
- The Court, and in many instances the Driving School, can grant you a continuance if you need more time to complete the class.

Pay the Fine

- Go to the webpage <https://eservices.scottsdaleaz.gov/Court/Case/> :
- Pay in full or request a payment plan by entering the complaint number and selecting your case.
- Mail a check or money order for your payment to the address listed above.
- You can also request a payment plan by filing an online motion or emailing the court at Court@ScottsdaleAZ.gov

Insurance, Registration, License charges

- Submit proof of insurance for the date of the violation in order to have a charge dismissed.
- Or submit proof of insurance after the date of violation and a copy of your 3 year driving record from Arizona Department of Motor Vehicles to have the fine reduced.
- Proof of Insurance must include the vehicle listed on the citation, or the name of the driver who was cited.
- For registration charges, submit proof of current registration, proof of sale or transfer of the vehicle, or proof of non-ownership for a possible reduced fine.
- If you were cited for not having your driver's license in possession, submit a clear copy of your license for a possible dismissal or reduced fine.
- If you were cited for driving on a suspended license, submit proof or reinstatement for a dismissal of the charge. If you are working on reinstating your license, you may request an extension by email or by filing an online motion.

Civil Traffic Hearing Information

- If you wish to dispute your charge, submit a written request for a hearing.
- Your hearing date will be mailed to you with complete instructions. Failure to appear for a hearing will result in a default judgment being entered against you.
- **Important:** Once the hearing begins, you can no longer attend Defensive Driving Class and if you are found responsible.

IF YOU LIVE OUTSIDE THE STATE OF ARIZONA OR HAVE A SUBSTANTIAL HARDSHIP which prevents you from physically attending a hearing AND you wish to plead not responsible for the violation(s), you may qualify for a Documentary Hearing pursuant to Rule 10 Civil Traffic Rules. This will allow you to file a written declaration of the facts surrounding the violation rather than appear in person at a hearing. The written request for a Documentary Hearing must be received prior to your appearance date.

Photo Enforcement

If you fail to respond to this complaint, you may be personally served at your own expense, your driver license may be suspended, and a default judgment may be issued.

Listed below are VIOLATION CODES with fine amounts including Mandatory State surcharges and assessments. If payment is **NOT RECEIVED** by the court date on your ticket, a \$20 Time Payment Fee per case plus an additional \$75 Default Fee on each civil charge will be imposed.

- 28-701.02A1 thru 28-701.02A3 MUST APPEAR IN COURT and are only eligible for Defensive Driving School with the express permission of a Judge.
- 28-2532 Registration violation. If appropriate license plates or registration is obtained after violation, the charge is eligible for dismissal.
- A.R.S. 28-3169A – No Driver License in Possession: Dismissed upon proof of driver license valid on the date and time of the violation. Provide a copy of both front and back of your driver license.
- A.R.S. 28-4135B & C – No Proof of Insurance: \$1,063.00 fine for a 1st offense. If you provide proof on or before your appearance date showing that the vehicle involved was insured on the DATE & TIME

the complaint was issued, the charge will be dismissed.

- A.R.S. 28-907A – Child Passenger Restraint: If you have been cited for “failure to use”, the fine is \$209.10. However, if you attend CAPP (Children Are Priceless Passengers) program, the fine will be suspended with proof of completion. Call the court for further information.
- A.R.S. 28-645A3A – Red-Light Violations: Persons found responsible or entering a plea of responsible for red-light traffic control signals, including flashing stop signals violations, will be ordered by the Motor Vehicle Division to attend and successfully complete Traffic Survival School or suffer suspension of driving privileges.
